

# Merit Tufted 5-Year Spikeproof Carpet Warranty

Durkan warrants the following carpets for a period of five (5) years against excessive wear from the date of installation. Wear is the abrasive loss, in excess of 20%, of the face fiber of the carpet. Abrasive wear is the loss of fiber through normal conditions (as determined by Durkan).

**Warranty Exclusions:** This warranty does not apply if one or more of the following conditions exist.

1. Stains, burns, tears, cuts, pulls, or improper use of abusive materials.
2. Pile crushing/matting, shading, bearding/fuzzing, and water marking/pooling.
3. Improper cleaning agents or methods.
4. Carpet installed on stairs or ramps.

Durkan provides this warranty to its customers. The warranty provided herein constitutes the sole and entire agreement between Durkan and supersedes all prior agreements, understandings, and/or negotiations, both written and oral, with respect to the goods ordered. Durkan's sole obligation under the warranty provided herein is to repair or replace the carpet pursuant to the terms set forth above. Durkan will not be responsible or liable for direct, indirect, special, incidental, consequential, exemplary or punitive loss or damage or cost, relating to replacement or refund. This warranty gives you specific legal rights, and you may have other rights that vary from state to state.
